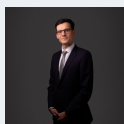
Investment style

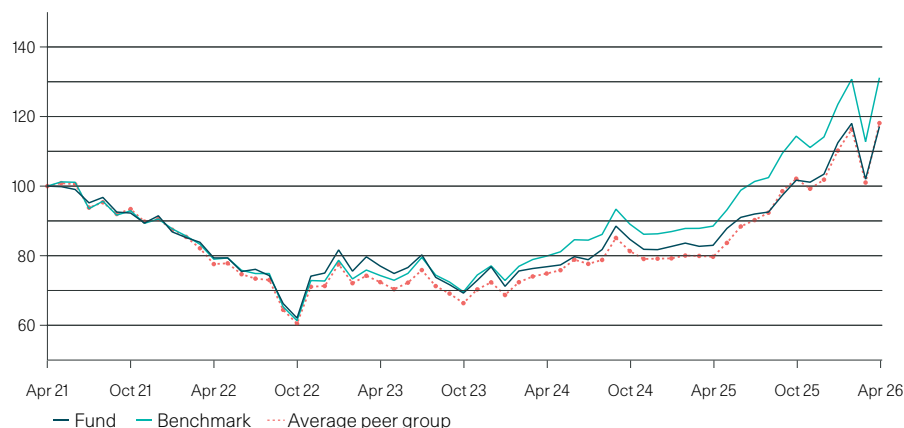
