Investment style

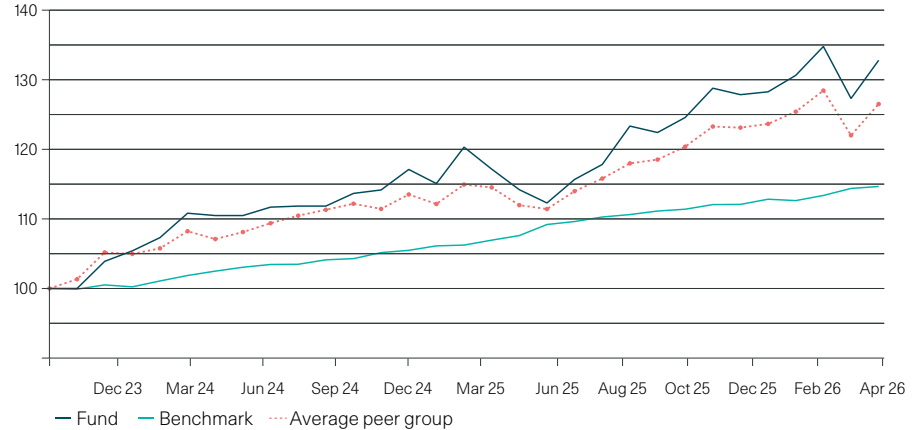

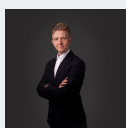

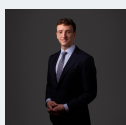
