Fund aim

The aim of the Fund is to provide long term (in excess of 5 years) capital growth, by investing in a portfolio of global, including UK, equities and equity related securities.

Investment style

The fund equities exposure (both direct and indirect) will be between 60% and 90%, typically 75%. The Fund may invest in other CIS's (open and closed ended), bonds, deposits, cash, near cash, money market instruments, warrants and structured products. The Fund can gain indirect exposure to property and commodities via CIS's. Derivative or forward transactions for investment purposes or EPM may be used.

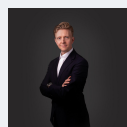
