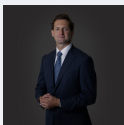
Investment style

The Fund will actively allocate between various alternative asset classes and seeks consistent returns with lower volatility than equity based investments.

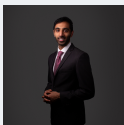

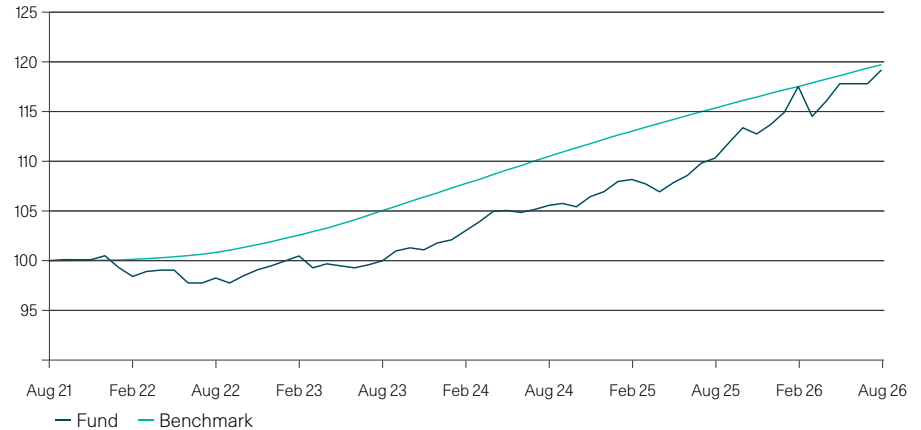
