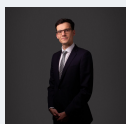
Investment style

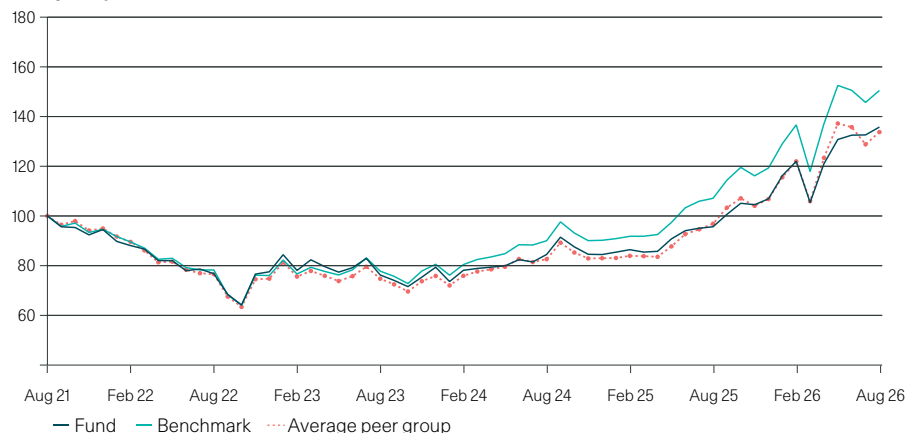
