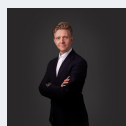
Investment style

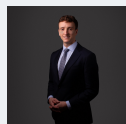

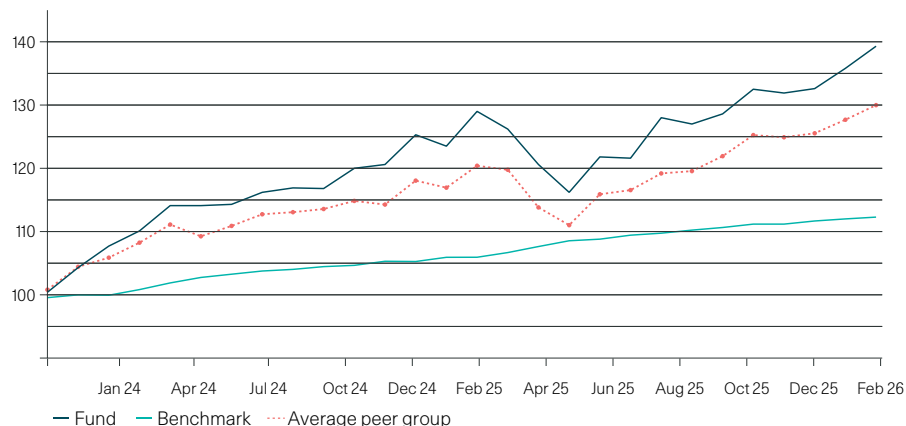
