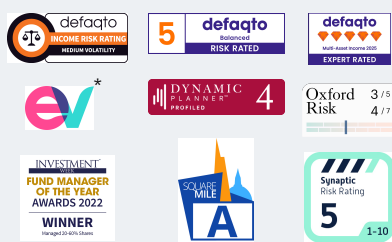
Investment style

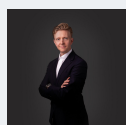

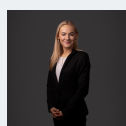

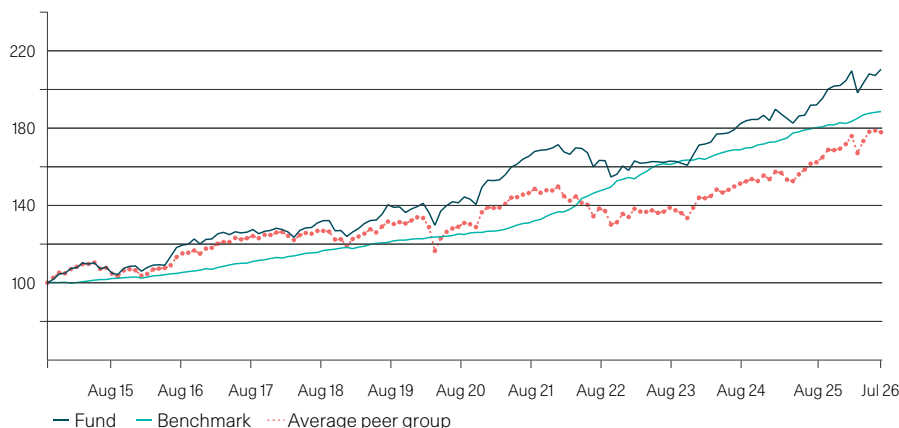
