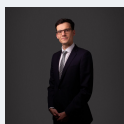
Investment style

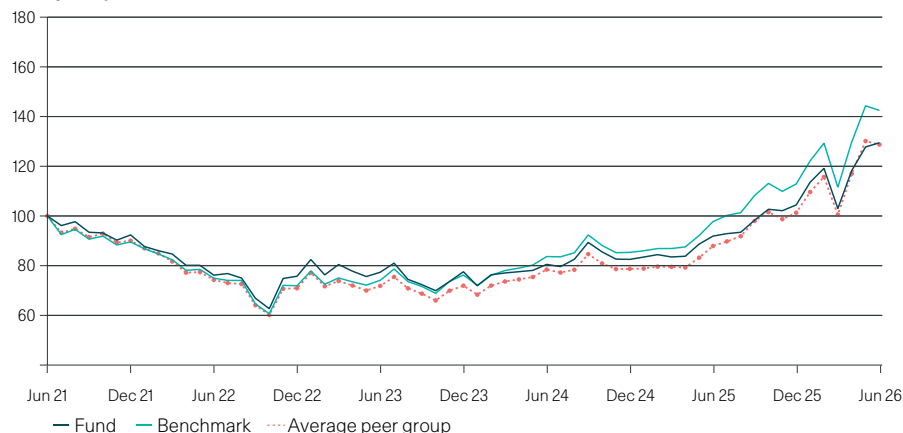
