The investment objective of the Fund is to achieve returns in excess of the MSCI AC World NR through investment in a focused selection of equities on a global basis.

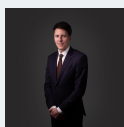
Investment style

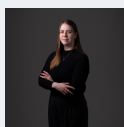

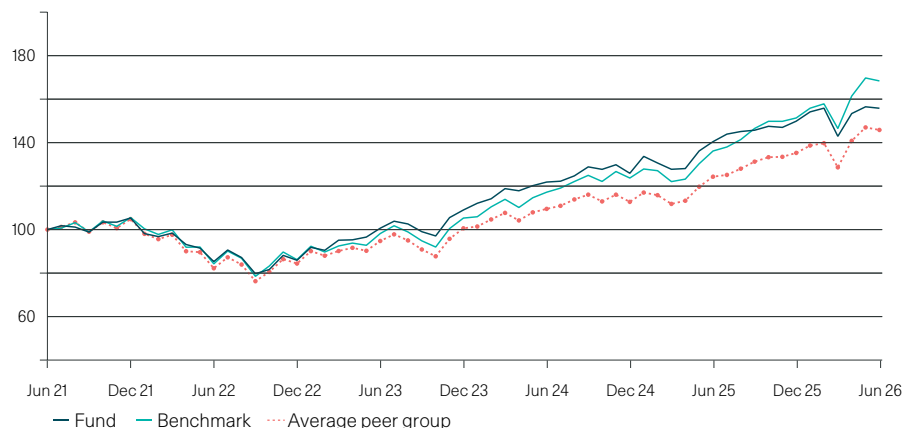
