Investment style

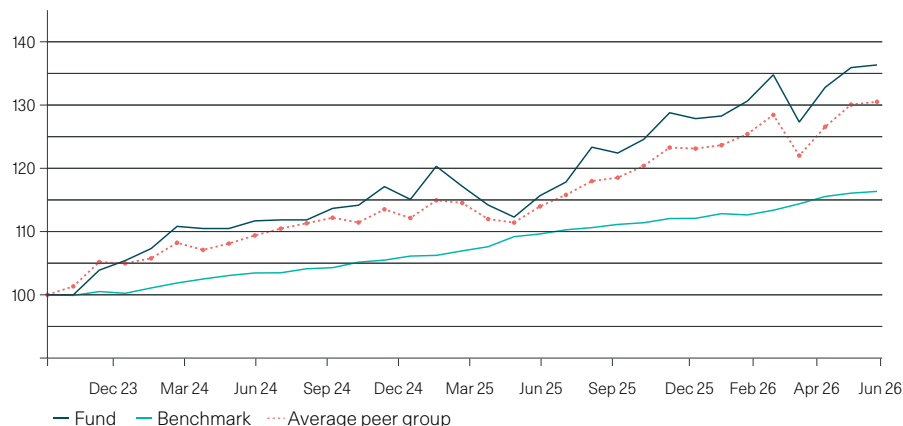

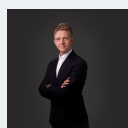

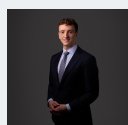
