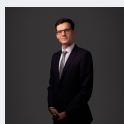
Investment style

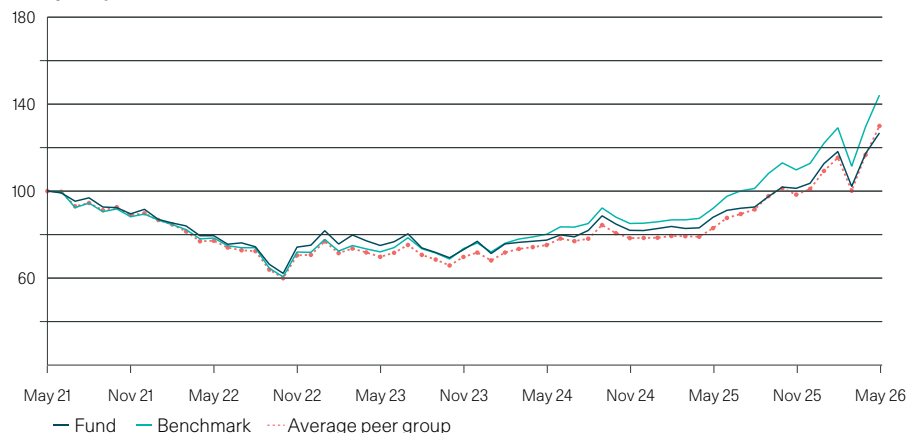
