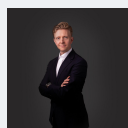
Investment style

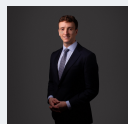

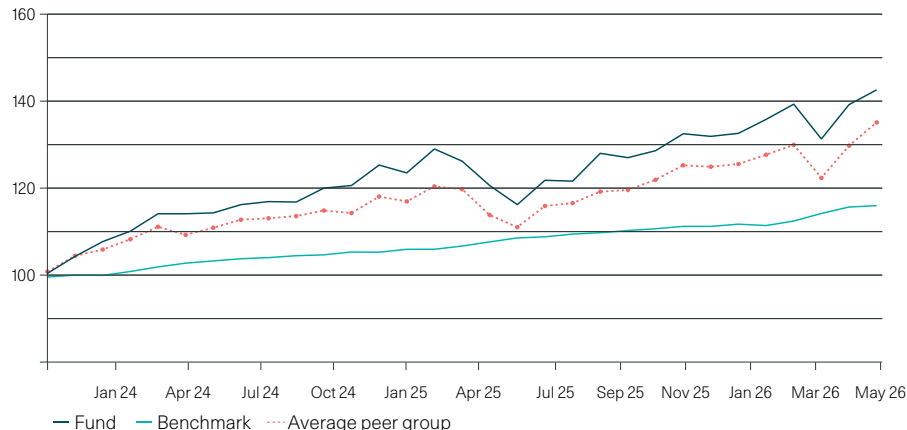
