Important Information

This supplement (the "Supplement") forms part of, and should be read in conjunction with, the prospectus (the "Prospectus") issued, and may be amended from time to time, by Waverton Investment Funds plc (the "Company"), a UCITS umbrella fund with segregated liability between its sub-funds pursuant to the UCITS Regulations. Unless otherwise defined herein, capitalised terms used in this Supplement shall have the meaning given to them in the Prospectus. To the extent that there is any inconsistency between the Supplement and the Prospectus, the Supplement shall prevail. Details of the other Funds offered by the Company are specified in the Prospectus and will be available on request.

The Company has obtained the approval of the Central Bank for the establishment of the Fund as a UCITS pursuant to the UCITS Regulations.

The distribution of this Supplement and the Prospectus and the offering or purchase of the Shares may be restricted in certain jurisdictions. No persons receiving a copy of this Supplement or the accompanying application form in any such jurisdiction may treat this Supplement or such application form as constituting an invitation to them to subscribe for Shares, nor should they in any event use such application form, unless in the relevant jurisdiction such an invitation could lawfully be made to them and such application form could lawfully be used without compliance with any registration or other legal requirements. Accordingly, this Supplement does not constitute an offer or solicitation by anyone in any jurisdiction in which such offer or solicitation is not lawful or in which the person making such offer or solicitation is not qualified to do so or to anyone to whom it is unlawful to make such offer or solicitation. It is the responsibility of any persons in possession of this Supplement and any persons wishing to apply for Shares pursuant to this Supplement to inform themselves of, and to observe, all applicable laws and regulations of any relevant jurisdiction. Prospective applicants for Shares should inform themselves as to the legal requirements of so applying and any applicable exchange control regulations and taxes in the countries of their respective citizenship, residence, incorporation or domicile.

SUMMARY OF PRINCIPAL TERMS

The following is a summary of the principal terms of the Fund. The following summary is qualified in its entirety by reference to the detailed information appearing elsewhere in this Supplement and by the terms and conditions of the Articles, the Prospectus and the subscription documents of the Fund, which should be read carefully by each prospective shareholder before investing.

Investment Objective	The investment objective of the Fund is to achieve capital growth and generate income through investment of up to 100 per cent. of its assets in a diversified portfolio of equities, fixed and/or floating rate global government and corporate Debt Securities, Structured Products, deposits, cash, money market instruments and collective investment schemes which may themselves invest in the foregoing asset classes and commodities to the extent that these are permitted by the UCITS Regulations.

	<p><i>There can be no assurance that the Fund will achieve its investment objective. It is recommended that for retail investors an investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.</i></p>
<p>Investment Policy</p>	<p>The Fund’s investment strategy shall not be specific to any particular industry sector or geographic region. The Investment Manager seeks to identify a combination of investments that have the potential to produce positive real returns (i.e., returns in excess of UK inflation, as measured by the UK Consumer Price Index) over a medium to long-term investment horizon and provide income through the investment cycle. The Investment Manager applies a “top-down meets bottom-up” approach, whereby the Investment Manager uses both the top-down and bottom-up investment views that it generates across equities, fixed income and alternatives. Alternatives include, but are not limited to, real estate, infrastructure, commodities, asset financing, and specialist lending. Exposure to these assets may be obtained via direct and indirect investments in equities, government and corporate Debt Securities, Structured Products, deposits, cash, money market instruments, ETFs, exchange traded notes and investment trusts which may themselves invest in the foregoing asset classes to the extent that these are permitted by the UCITS Regulations.</p> <p>The top-down asset allocation overlay is determined by the Investment Manager by identifying key risks to the global economy and markets, and analysing macroeconomic data and market fundamentals. The bottom-up investment selection process is conducted by the Investment Manager across all asset classes and seeks to identify companies with attractive absolute, relative and risk adjusted return performance characteristics. First, the Investment Manager uses basic quantitative screening to highlight potential investment opportunities. Next, the Investment Manager carries out detailed and comprehensive qualitative company (or strategy) due diligence by conducting research and meetings with target issuers. Once these steps are completed, the Investment Manager assesses whether the investment opportunity appears attractive from an economic perspective, and identifies the expected risk and return characteristics of the researched position. Finally, the Investment Manager decides whether to proceed with the investments based on the results of this analysis. When selecting collective investment schemes, the Investment Manager first defines the universe of eligible investments, and then applies a proprietary fund selection screen to filter and rank each fund on a range of quantitative performance characteristics, with a focus on risk and consistency of returns. Then a quantitative analysis is undertaken to understand and evaluate the performance track record of each investment, followed by a detailed qualitative assessment of the investment approach and process. This assessment involves the Investment Manager conducting on-going research, evaluation and monitoring activities, and for those collective investment schemes that are selected for investment, the Investment Manager will meet the investment manager of the relevant collective investment scheme at least every 12 months, and more frequently if there is an important event, such as unusual levels of volatility or an identified change in investment style.</p> <p>The Fund may invest up to 60 per cent. of its Net Asset Value in equity securities issued by companies with any market capitalisation which may include ordinary shares or common stock, preference shares, ETFs, investment trusts, American depository receipts, European depository receipts and global depository receipts which generally are listed, traded or dealt in on a Regulated Market.</p> <p>The Fund may invest up to 70 per cent. of its Net Asset Value in Debt Securities (by way of direct investment or through the use of collective investment schemes</p>

to provide exposure to the underlying asset class), such as OECD government or supranational Debt Securities, corporate Debt Securities, bankers' acceptances and commercial paper and in Convertible Debt Securities. The Debt Securities in which the Fund invests shall not be from any particular industry sector. The Debt Securities may be either investment grade or below investment grade rated by a rating agency such as Moody's or Standard & Poor's. Up to 35 per cent. of the Net Asset Value of the Fund may be invested in Debt Securities that are rated below investment grade. The Debt Securities may be denominated in any currency. The Fund may invest up to 10 per cent. of its Net Asset Value in contingent convertible securities.

Not more than 30 per cent. of the Net Asset Value of the Fund will be invested in securities of issuers established in Emerging Market Countries.

Investment in UCITS and UCITS Equivalent Schemes shall be subject to an aggregate limit of 10 per cent. of the Fund's Net Asset Value. The Fund may not invest more than 10 per cent. of its Net Asset Value in any one collective investment scheme. The collective investment schemes in which the Fund invests will be established as UCITS under the Directive and/or UCITS Equivalent Schemes. The underlying collective investment schemes in which the Fund may invest will provide exposure to one or more of the asset classes which form part of the Fund's investment policy.

Investment in Structured Products shall be subject to an aggregate limit of 30 per cent. of the Fund's Net Asset Value.

The Fund may utilise any of the financial derivative instruments described in the section entitled "Investment Techniques and Instruments" for efficient portfolio management and/or investment purposes.

The Fund may acquire Shares in another sub-fund of the Company by investing up to 10 per cent. of its Net Asset Value in that other sub-fund. However, the Fund may not invest in a sub-fund of the Company which itself holds Shares in other sub-funds of the Company. Where the invests in another sub-fund of the Company or any other fund managed or advised by the Investment Manager, it may not charge an annual management and/or investment management fee in respect of the portion of its assets invested in the other sub-fund/fund.

Furthermore, the Fund may hold Ancillary Liquid Assets where in view of market circumstances the Investment Manager believes that it would not be in the interests of Shareholders for the Fund to be fully invested or where the Fund needs to maintain liquidity to meet repurchase requests.

Leverage and Long / Short Exposure

It is possible for the leverage of the Fund to be as high as 200 per cent. of the Fund's Net Asset Value, whereby leverage is calculated as the sum of the notional of the derivatives used. Please see the section entitled "Measurement of Market Risk and Leverage" for additional information.

It is anticipated that the notional exposure of the Fund to long and short positions will be up to 100 per cent. and 100 per cent., respectively, of the Net Asset Value of the Fund.

Payment will be made to all Shareholders who held Shares at the ex-dividend date of 31 January, 30 April, 31 July and 31 October in the relevant year (or in the event that any of these dates does not fall on a Business Day, the Business Day preceding that date).</p> <p>It is proposed that dividends will not be declared in respect of the Class P Stg£ Acc Shares and PI Stg£ Acc Shares of the Fund.
