Portfolio objective

The W1M (Waverton) Cautious Portfolio is intended for investors with a medium attitude to risk and a minimum time horizon of 5 years. The portfolio seeks a longer term return of 3.0% above inflation measured by the UK Consumer Price Index (CPI).

Portfolio overview

The portfolio seeks to provide a diversified interest in a variety of asset classes and the realistic prospect of capital growth and income over the longer term within acceptable risk parameters. Importantly, we expect little correlation between equities, bonds and selected alternative asset classes so the portfolio should provide some degree of protection during periods of equity market weakness.

The portfolio is invested through a mix of four specialist W1M funds: Sterling Bond Fund, Strategic Equity Fund, Real Assets Fund and Absolute Return Fund.

Commentary

Q2 returns for the W1M (Waverton) Managed Portfolio Service on Platform ranged from +5.0% to +9.2%.

Equities - Markets were boosted by easing geopolitical tensions in Q2, hopes of inflation pressures easing, and strong earnings growth led by semiconductor and memory stocks. The return of “concentration” in equity markets was evident, with around 70% of global equity (MSCI ACWI) returns driven by US and Asian technology stocks. Narrow market leadership from semis hardware, primarily led by memory names in Asia, and a reversal of sentiment from peace talks in the Middle East dragging on sectors like Energy, did not help our equity portfolios, but a double-digit return was achieved in Q2 nevertheless.

Looking ahead, we expect a broadening out given a supportive global macro outlook as inflationary pressures ease and growth remains positive. In addition, corporate investment plans are well supported by a US industrial recovery and corporate earnings expectations remain strong.

Fixed Income - Following a post-pandemic inflation spike, bond yields globally have firmly moved into more normal historical ranges after a long period of “zero interest rates” and quantitative easing policies around the world.

Global growth remains positive. As inflation has moderated from peak levels, US and UK government bond yields have begun to subside. Markets are no longer expecting interest rate cuts in the UK and US this year, but the inflation outlook is becoming more favourable, which could allow lower rates next year.

Absolute Return - Structured opportunities were the largest positive contributors over Q2, benefiting from the recovery in global equity markets. Price dispersion continued to perform well amidst elevated single stock volatility, benefiting from single stock moves in the AI and semiconductor space in particular. The fund aims to have differentiated return streams with low directional beta, reinforcing its role as a diversifier in broader portfolios.

Real Assets - Real assets continued to deliver positive returns. Performance was driven by continued investment in power and grid infrastructure, accelerating electricity demand from AI and data centres, and increasing recognition of the need for significant network upgrades. Commodities detracted from performance, predominantly driven by gold, which corrected over the quarter following an exceptionally strong period of returns. Real assets remain supported by powerful structural drivers: government-backed infrastructure programmes, grid modernisation and the accelerating energy transition.
