

This document is a record of how W1M exercised its voting rights for investments in its proxy voting universe, comprising the holdings in Waverton and London & Captial's equity funds (prior to the convergence of AUM over the last year and merger of the funds in December 2025). This covers the majority of our equity AUM. The merger also introduced a number of complexities around different pools of assets, which continue to influence how voting is reported.
